Welcome and Opening Remarks by President:

Kate welcomed the members attending her first board meeting as president. In addition, she welcomed new board members Lisa MacDonald and Jenni Madsen-Kamp

Approval of the June 4, 2025 Meeting Minutes:

A motion to approve the June 4th meeting minutes was made by Darci, seconded by Rick. The motion was approved.

Financial Report – Lisa MacDonald

Lisa reported that as of 06/30/2025 we had a total bank balance of \$970,692. Also, 60-89 days delinquent accounts have been reduced to \$294.27 and 90 + days delinquent accounts to a total of: \$5473.97.

Commissioners - Reports attached:

Beach-Darci Russell:

In addition to the attached report, the first Island beach event is scheduled for Saturday, August 9th. Also, everyone needs to be reminded to clean up their garbage when using the beach. Pack it in; Pack it out!

Dock-Jenni Madsen-Kamp:

In addition to the attached report, Jenni gave a special thank you to Nancy and Pat for all of their work around the dock area.

A hose will be added to the bottom of the dock that can be connected to the upper hose.

In addition, a new life ring has been purchased for the dock. Jenni will research adding a second smaller ring if needed.

The gates will be painted this week.

Bridge-Rick Buran:

In addition to the attached report, the planter drips have been fixed and all have water. A reminder to not move the caps on the top of the new lights as the lights will stay on if the caps are closed.

Roads-Rick Buran:

In addition to the attached report, the speed bumps need to be repainted and Rick is researching painters to do this.

A bid has been received to clean up the path between #941 & #921, to include building a fence and putting down gravel. The board approved to spend up to \$4600 for this project.

Trees by the dock and at the beach are being limbed and one tree by the dock is being removed. A bid for this project for \$5729.30 has been approved.

Water-Joe Ragucci:

Members are reminded that leaks on the customer side of the shut-off need to be fixed by the owner.

It is possible that we will need to schedule a shut-down to the entire Island to fix a damaged valve. Members will be notified in advance if this occurs.

Members are reminded that they are responsible to have one or more water shut-offs on their property in addition to the Island shut-off on the road.

NW water has been asked to give us a price to put shut down valves in four quadrants to segment the island for future repairs.

A bid was received for cleaning the outside of the water tank but was more expensive than expected. Less expensive options will be explored for the future.

Reliable Electric will be contacted to install electrical boxes on the outside of the pump houses.

Old Business:

- Bridge Planters-Jenni will form a committee to explore options for enhancing the planters on the bridge.
- Island Historians-Marianne Howard and Diana Scott have agreed to be our Island Historians.
- Bridge Anniversary - Rod Wilkerson will coordinate a celebration for the 15th anniversary of the bridge.

New Business:

- SB5129 Overview -This new law will take effect January 1, 2026 and will impact some Board operations, with the focus on enhancing member participation.
Two changes that will be implemented now are:
 1. Beginning with the October board meeting, “Member Comments” will be moved to the beginning of the meeting.
 2. Board minutes will now be emailed to all members following each meeting.

The Board will be working on ways to adapt to the required changes and will provide updates at the October and December board meetings.
